The Secretary called on the following speaker:

Mr. Luis Schmidt, an American Federation of State, County, and Municipal Employees (AFSCME) Local 18 representative, addressed the Committee regarding personnel related matters. He stated that great progress has been made in labor negotiations. There are a couple of outstanding items, which he expects to be resolved at the next meeting. He requested that the Committee give authorization to the negotiation team to meet AFSCME half-way. The biggest request is to reduce the probationary period from one year for hourly classifications that will be converted to monthly. There are three to four outstanding important main items, which are expected to be resolved by Monday.

RE: UPDATE ON DISTRICTS' POST-STORM ACTIVITIES FOLLOWING FEBRUARY 1ST AND 4TH – 6TH STORMS - DISCUSS

The Chief Engineer and General Manager provided a report on the Districts' post-storm activities following the recent storms in early February. As previously reported, the Districts' sewer system experienced

significant inflow in early February due to widespread street flooding and illegal discharges. One Sanitary Sewer Overflow (SSO) located in Rancho Dominguez spilled a total of 8 million gallons, and wastewater ran into the Dominguez Channel, Los Angeles River, and the harbor and ports of Long Beach.

Districts' field staff sealed manholes upstream of one of the spill locations and observed the locations in the subsequent smaller storms, as was shown on photos. Corking and sealing all manhole covers could prevent future SSOs, although the issue of street flooding remains. City staff would need to mitigate issues related to storm drains by clearing filters, which reduces capacity. Additionally, Industrial Waste inspection staff inspected businesses and industries with sewer connections upstream of specific spill locations to locate any illegal connections and discharges.

He introduced Mr. Brian Louie, Department Head of Wastewater Management, and Ms. Kristen Ruffell, Assistant Department Head of Wastewater Management. They reviewed flow meter data and are available to answer any questions regarding this matter.

As inflow hotspots are identified, staff is performing field inspections to look for potential sources. A map, as was shown on a slide, showed the tributary area to a spill in Palos Verdes. Field staff found a damaged manhole and contacted the Los Angeles County Public Works to get it repaired. In some cases where the source isn't obvious on the surface, the flow at junction manholes can be observed during a storm to point toward the source. Inspections of industrial facilities that discharge their industrial sewage to our system have resulted in 50 rain related enforcement actions, including 31 written Notices of Violations and 19 verbal warnings. Districts' staff is also working with several cities (Commerce, La Mirada, Long Beach, Rancho Palos Verdes, Rolling Hills Estates, Vernon, and Whittier) to identify inflow hot spots based on the flow monitoring data recently collected. With the flow monitoring data, Districts' staff can review the peaking factors (the ratio of peak flow to average daily flow) from these flow monitors in certain sewer lines. When peak flows are more than two times the dry weather average flow, there is significant cause for concern that will trigger an investigation to identify and control stormwater inflow.

Inflow from flooding is controlled by corking and sealing manhole covers that are subject to flooding, and by finding and stopping illegal discharges. Staff is utilizing flood maps published by the University of California, Irvine (UCI), to determine areas in our member cities where street flooding potentially occurs. The UCI-published flood map (as was shown on a slide) showed areas in Los Angeles County with a 100-year Composite Flood Hazard rating. Flood mapping, such as this one published by UCI, gives a good indication of high-risk areas, like Commerce, as was shown on a map, where corking and sealing of manholes should be prioritized.

A map of the Districts' service area including local sewers (shown in green) that are tributary to the Districts' sewers (shown in blue) and managed by member cities and/or the County Sewer Maintenance Division of Los Angeles County Department of Public Works was shown on a slide. A letter was previously sent to City Managers and Public Works Directors regarding action requested to prevent sewer overflows during storms. The Districts is seeking countywide approval to cork and seal all local city sewer manholes that appear to be subject to flooding. Furthermore, the Districts are requesting the cities' assistance to reseal any manhole they find sealed as a result of Districts' inflow investigations. Public Works Directors will be contacted about this new inflow prevention program being initiated by the Districts, following concurrence from the Committee. In some cases, the source of inflow is not apparent by canvassing the surface. In these cases, Districts' staff would need assistance from the cities to plan a smoke/dye test to locate the sources. Finally, all local city staff should be reminded that the sewer (whether Districts or local city sewer) should never be used to drain stormwater. This should only be allowed under limited circumstances with a permit from the Districts and proper controls to delay the discharge until capacity is available.

One Director requested a video recording of the presentation providing a report on the impact in Districts' operations from the February 1st and 4th – 6th storms.

The Committee concurred with staff's recommendation to seek countywide approval to cork and seal all local manholes that appear to be subject to flooding, request the cities' assistance to reseal any manhole they find sealed as a result of this program, and support Districts' staff on the implementation of follow-on investigation such as smoke/dye tests to locate sources of inflow, as necessary.

In response to Director Saro, the Chief Engineer and General Manger stated that the letter to the City Managers and Public Works Directors is scheduled to be distributed in May. The work will be planned through summer and fall. All local Directors will be copied to ensure that the cities follow through. He plans to report on the status of this matter in the fall.

RE: DIRECTOR COMMENTS

Director Woods requested that the item regarding Director compensation be added to the next agenda.

The Chief Engineer and General Manager stated that at the March 27, 2024, meeting the Committee recommended to institute a cost-of-living adjustment (percent increase based on CPI for LA-Long Beach, not to exceed 5 percent), and bring the matter before the District Boards in fall with the effective date of January 2025.

The Chairperson requested a vote to bring the matter back at the next meeting. A majority of the Directors present voted in favor to bring the item back to the Committee for discussion and possible further recommendations.

Upon motion of Director Saleh, duly seconded and unanimously carried, the meeting adjourned.
