#### CONDITIONS FOR THE PERMIT FOR WASTEWATER TRANSPORT TRUCK TO DISCHARGE TO THE SEWERAGE SYSTEM

The applicant is required to comply with the following conditions for this permit:

#### **Waste Discharge Requirements**

- 1. To discharge wastewater only at approved locations; discharging wastewater to any other location is a violations of the *Wastewater Ordinance*, and such a person may be prohibited from future use of the Sanitation Districts' sewerage system, and may also be subject to fines and penalties provided by law and the *Wastewater Ordinance*.
- To discharge only wastewater from septic tanks, cesspools and portable toilets at the approved locations; discharge to other wastes is prohibited
  unless a Sanitation Districts' Industrial Wastewater Discharge Permit has been obtained by the wastewater generator with specific permission to
  discharge wastewater at an approved location.
- 3. To notify the Sanitation Districts immediately (562) 699-7411 and ask for the Industrial Waste Section, or (562) 437-6520 (after hours), in the event that material which might constitute a hazard to Sanitation Districts' personnel, wastewater treatment facilities or the environment was discharged to the sewer.

#### **Permitting Requirements**

- 4. To allow the discharge of wastewater to the sewerage system only from the tanker truck or tank trailer identified in this permit; this permit and the accompanying identification materials are not transferable to another vehicle.
- 5. To apply for a new permit when the ownership of the company or of the truck changed; please ensure that the permit and other identification materials issued by the Sanitation Districts are not transferred or assigned.
- 6. To affix an identification decal and an electronic tag issued by the Sanitation Districts on the truck tank according to the direction of the Sanitation Districts. The decal and tag are the properties of the Sanitation Districts and must be surrendered to the Districts upon request or upon cancellation or revocation of the permit.
- 7. To carry evidence of proper and valid county health department registrations and licenses, as required.
- 8. To pay in a timely manner all applicable permit fees, renewal fees and wastewater disposal fees.
- 9. To accept and abide by all provisions of the *Wastewater Ordinance* of the Sanitation Districts of Los Angeles County; violation of any provision of the *Wastewater Ordinance* may result in the revocation of this permit and prohibition from future use of the Districts' sewerage system for liquid waste disposal, or criminal prosecution.

### Operations Requirements at the Liquid Waste Disposal Station

- 10. To equip the truck with a hose of sufficient length and having 4-inch diameter male cam and groove coupler that is compatible with equipment at the wastewater disposal stations to minimize spillage and odor emission, and to provide a sampling location at the top of the waste tank for collecting a column sample of the waste, minimum 3-inch in diameter, and the necessary tools to gain access.
- 11. To completely wash out the waste holding tank after hauling hazardous, industrial or other prohibited wastes, and to ensure that all such materials are removed before wastewater is hauled for discharge to the sewerage system.
- 12. To cooperate at all times with Sanitation Districts' personnel in the inspection and sampling of wastewater transported for discharge to the sewer
- 13. To provide the Sanitation Districts with a certified waste analysis before the waste is accepted for disposal if so requested by the Sanitation Districts.
- 14. To submit a manifest of the waste to be discharged before it is accepted for disposal, showing the name, address and phone number of the waste generator, the type of waste and the approximate volume of waste; and to maintain and submit, as required by the Sanitation Districts, waste hauling records, wastes manifests and any other documentation needed to verify the nature and origin of wastes discharged or to be discharged.
- 15. To provide access to Sanitation Districts' representatives to the truck and truck yard area for inspection purposes.
- 16. To observe all rules at the approved wastewater disposal stations.
- 17. To furnish additional information on the wastewater transported for disposal to the sewerage system as required by the Sanitation Districts.
