The Sanitation Districts' Connection Fee Program requires all new users of the sewerage system, as well as existing users who expand their wastewater discharge, to pay a connection fee to the Sanitation Districts based upon the quantity and the strength of the wastewater discharge. All industrial companies discharging wastewater into the Sanitation Districts' sewerage collection system are required to pay their fair share of the treatment costs through either the Service Charge Program or the Surcharge Program. This talk will provide additional information about the Connection Fee Program and will briefly discuss required information to complete and file the annual Surcharge Statement.
