Key Legislative Issues: Plastics

- Circular Economy & Plastic Pollution Reduction
 - SB 54 (Allen) / AB 1080 (Gonzalez)
 - Stalled in 2nd house. 2-year bill.
 - AB 129 (Bloom) & AB 223 (Stone)
 - Stalled in 1st house. 2-year bill.





Key Legislative Issues: Wipes

- Labeling for "Flushable" Wipes.
 - AB 1672 (Bloom)
 - Stalled in 1st house. 2-year bill.





Key Legislative Issues: Toxics

- CA Safe Cosmetics Act
 - AB 495 (Muratsuchi)
 - Stalled in 1st house. 2-year bill.
- Toxic Fragrance Chemicals Right to Know Act
 - SB 574 (Leyva)
 - Stalled in 2nd house. 2-year bill.





Key Legislative Issues: Ocean Discharge & Resiliency

- Ocean Discharge Prohibition (95% Recycling Requirement)
 - SB 332 (Hertzberg & Wiener)
 - Stalled in 2nd house. 2-year bill.
- Ocean Resiliency Act
 - SB 69 (Wiener)
 - Stalled in 2nd house. 2-year bill.





Key Legislative Issues: Stormwater

- General Industrial Stormwater Permit Compliance Check
 - SB 205 (Hertzberg)
 - Enacted on 10/02/19. Takes effect on 01/01/20.
- Tire Fee for MS4 Compliance
 - AB 755 (Holden)
 - Stalled in 1st house. 2-year bill.
- Water Board to Adopt Guidelines for Assessing Financial Capability for MS4 Permittees
 - AB 1093 (Rubio)
 - Vetoed on 09/27/19.





Key Legislative Issues: PFAS

- PFAS (Per- and polyfluoroalkyl Substances)
 - AB 756 (C. Garcia) & AB 841 (Ting)
 - Enacted on 07/31/19. Takes effect on 01/01/20.





Key Legislative Issues: Air Quality

- Heavy-Duty Vehicle Inspection and Maintenance Program
 - SB 210 (Leyva)
 - Enacted on 09/20/19. Takes effect on 01/01/20.
 (Pilot Program)





Key Legislative Issues: Recycling

- Water: Recycled Water
 - AB 1180 (Friedman)
 - Enacted on 10/02/19. Takes effect on 01/01/20 and 01/01/23.
- State Recycling Market Development Act
 - AB 1583 (Eggman)
 - Enacted on 10/09/19. Takes effect on 01/01/20.
