8. Impacts Found Not to Be Significant

California Public Resources Code Section 21003(f) states: "...it is the policy of the state that...all persons and public agencies involved in the environmental review process be responsible for carrying out the process in the most efficient, expeditious manner in order to conserve the available financial, governmental, physical, and social resources with the objective that those resources may be better applied toward the mitigation of actual significant effects on the environment." This policy is reflected in the California Environmental Quality Act (CEQA) Guidelines Section 15126.2(a), which states that "a[n] EIR [Environmental Impact Report] shall focus on the significant environmental impacts of the proposed project" and Section 15143, which states that "the EIR shall focus on the significant effects of the environment." The Guidelines allow use of an Initial Study to document project effects that are less than significant (CEQA Guidelines Section 15063[a]). CEQA Guidelines Section 15128 requires that an EIR contain a statement briefly indicating the reasons that various possible significant effects of a project were determined not to be significant and, therefore, were not discussed in detail in the Draft EIR (DEIR).

8.1 ASSESSMENT IN THE INITIAL STUDY

The Initial Study prepared for the proposed project in February 2006 determined that the impacts listed below would be less than significant. Consequently, they have not been further analyzed in this DEIR. Please refer to Appendix A in Volume IIA for an explanation of the basis for these conclusions. Impact categories and questions below are summarized directly from the CEQA Environmental Checklist, as contained in the Initial Study.
