RE: FINANCIAL MANAGEMENT RELEASE OF ALL CLAIMS (PROPERTY DAMAGE ONLY) - PRIME PERFORMANCE CONTRACTORS, INC., AND KINSALE INSURANCE COMPANY - APPROVE On August 1, 2019, fiber optic conduits were discovered installed through District 17 Main Trunk Sewer. Through investigation, it was determined that on October 23, 2017, Prime Performance Contractors, Inc., (Prime Performance) installed the conduits through the sewer. Kinsale Insurance Company, Prime Performance's insurance carrier, offered

\$15,387.50 for the costs to repair the damages to the sewer in exchange for a signed release. This item is consistent with the Districts' Guiding Principle of commitment to fiscal responsibility and prudent financial stewardship. A recommendation was made to approve and order executed a *Release of All Claims (Property Damage Only)* with Prime Performance Contractors, Inc., and Kinsale Insurance Company relating to the damages to District 17 Main Trunk Sewer.

In response to Director Tornek, the Chief Engineer and General Manager stated that during routine maintenance, sometimes staff discover that other utilities go through or cause damage to sewer lines. At this particular time, conduits were installed through a portion of the District 17 Main Trunk Sewer.

Upon motion of Director Kuehl, duly seconded and unanimously carried by a roll-call vote, the Board of Directors of County Sanitation District No. 17 of Los Angeles County found and determined that it would be to the advantage of the District to enter into a *Release of All Claims (Property Damage Only)* with Prime Performance Contractors, Inc., and Kinsale Insurance Company providing for the costs to repair the damages to District 17 Main Trunk Sewer in exchange for a signed release, as set forth in the signed release and under terms and conditions contained therein. All the terms and conditions of the *Release of All Claims (Property Damage Only)*, dated September 23, 2020, were accepted and approved, and the Chairperson and Secretary were authorized to execute the signed release on behalf of the District.
