RE: COUNTY OF LOS ANGELES V. SANITATION DISTRICTS OF LOS ANGELES COUNTY - PUENTE HILLS LANDFILL PARK DEVELOPMENT - CONFERENCE WITH LEGAL COUNSEL-EXISTING LITIGATION - DISCUSS A dispute has arisen regarding the financial responsibility for development and maintenance of a park on the closed Puente Hills Landfill, as well as the permissible locations for park improvements. On February 27, 2020, the County filed a Complaint with the Court against the Districts. Representatives of the County and Districts have recently

met to discuss settlement of this case and tentative settlement terms have been drafted. The Chief Engineer and General Manager and Districts Counsel discussed this matter in closed session.

District Counsel advised that it would be in the interest of the District to meet in joint closed session pursuant to Section 54956.9(d)(1) of the California Government Code *Conference with Legal Counsel-Existing Litigation* to confer on the matter of one case – County of Los Angeles v. Sanitation Districts of Los Angeles County et al., Orange County Superior Court Case No. 30-2020-01153422; Puente Hills Landfill Park development.

Upon motion of the Chairperson pro tem, duly seconded and unanimously carried by a roll-call vote, the Board of Directors of County Sanitation District No. 29 of Los Angeles County met in joint closed session with the Boards of Directors of County Sanitation Districts Nos. 2, 3, 5, 15, 16, 18, 19, 21, 22, 23, and South Bay Cities Sanitation District of Los Angeles County at 12:22 p.m.

Upon motion of the Chairperson pro tem, duly seconded and unanimously carried, the meeting reconvened in joint regular session at 1:23 p.m. District Counsel reported that while in joint closed session, the Boards of Directors endorsed staff's recommendation to work on a settlement agreement including terms discussed and bring the final agreement to District No. 2 for approval on behalf of all Solid Waste Districts.
