

ASSET PURCHASE AND SALE AGREEMENT

This Asset Purchase and Sale Agreement (the "Agreement") is dated _____, 2022 (the "Effective Date") and is between **ARAKELIAN ENTERPRISES, INC.**, a California corporation, d/b/a Athens Services ("Athens") and **COUNTY SANITATION DISTRICT NO. 2 OF LOS ANGELES COUNTY**, a county sanitation district organized and existing pursuant to the County Sanitation District Act, California Health and Safety Code Section 4700 *et seq.*, (the "District") (collectively, the "Parties," and each individually, a "Party") with reference to the following facts:

A. The District is the owner of certain personal property consisting of (i) certain equipment, as described in Exhibit "A" (the "Equipment"), (ii) certain spare parts, as described in Exhibit "B" (the "Spare Parts", and each, individually, a "Spare Part"), and (iii) a number of bales ("Bales"), which bales consist of the commodities described on Exhibit "C" ("Commodities"). Each of Exhibits "A", "B" and "C" are attached hereto and made a part hereof.

B. The District desires to sell to Athens, and Athens desires to purchase the from the District, pursuant to the terms and conditions set forth in this Agreement, (i) all of the Equipment, (ii) those Spare Parts which are delivered to Athens as of the Closing Date (as defined below), and (iii) a number of Bales . Items (i), (ii), and (iii) in this Recital B are collectively referred to as the "Property".

NOW, THEREFORE, in consideration of the promises and the mutual covenants agreements, and conditions hereof, the Parties agree as follows:

1. Purchase and Sale. The District agrees to sell the Property, and Athens agrees to purchase the Property from the District, on and subject to the terms and conditions hereinafter described in this Agreement.

2. Purchase Price. The total purchase price for the Property which will be determined as of the Closing Dates is the sum of the amounts described in (a) through (c) below (the "Purchase Price"). The Purchase Price includes, without limitation, scrap value and the California Redemption Value for various commodities that are included in the Property.

(a) The portion of the Purchase Price applicable to the Equipment is \$1,547,300.00.

(b) The portion of the Purchase Price applicable to the Spare Parts is \$_____ which is the sum of the prices shown on Exhibit "B" for each Spare Part which is delivered to Athens as part of the Property.

(c) The portion of the Purchase Price applicable to the Bales is \$_____.

3. Time and Place of Sale. The purchase and sale described in this Agreement shall be consummated on August 1, 2022 (the "Closing Date") at the Puente Hills Materials Recovery Facility located at 2808 Workman Mill Road, Whittier, California 90601 ("MRF") as to any Property relating to and/or located at the MRF and at the Downey Area Recycling and Transfer Facility located at 9770 Washburn Road, Downey, California 90241 ("DART") as to any Property relating to and/or located at DART.

4. Payment of Purchase Price. On the Closing Date, Athens shall pay to the District the entire Purchase Price for the Property described in Section 2(a) through (c) in immediately available funds. Upon

receipt of the Purchase Price, the District shall deliver to Athens (i) a fully executed Bill of Sale (in the form attached hereto as Exhibit "D" and made a part hereof) conveying to Athens the applicable Property and (ii) the applicable Property. The Bill of Sale may be delivered electronically.

5. Ownership. The District represents and warrants that it is the sole owner of all beneficial interests in the Property and that no third party has title to, or any option or right to use, lease, purchase or otherwise obtain any benefit from, all or any portion of the Property.

6. Third Party Warranties. The Property includes any third-party warranties applicable to the Property, which the District hereby assigns to Athens and which Athens hereby assumes as of the Closing Date. Athens and the District each agrees to execute and deliver such additional documents and instruments and to perform such additional acts as may be reasonably necessary to effectuate the transfer or enforcement of such third-party warranties.

7. "As Is". Athens acknowledges and agrees that except as set forth in Section 4 and Section 5 above, the District has not made, does not make and specifically negates and disclaims any representations, warranties, promises, covenants, agreements or guaranties of any kind or character whatsoever, whether express or implied, oral or written, past, present or future, of, as to, concerning or with respect to (a) the Property, (b) the value, nature, quality or condition of the Property, (c) the suitability of the Property for any and all activities and uses contemplated by Athens, (d) the compliance of the Property with any laws, rules, ordinances or regulations of any applicable governmental authority or body, (e) the merchantability, marketability, profitability or fitness for a particular purpose of the Property, (f) the payment of sale taxes or any other taxes with respect to the Property, or (g) any other matter with respect to the Property. Athens further acknowledges and agrees that having had the opportunity to inspect and investigate all aspects of the Property, Athens is relying solely on its own investigations and inspections of the Property. The District is not liable or bound in any manner by any oral or written statements, representations or information pertaining to the Property, furnished by any person. Athens further acknowledges and agrees that the sale of the Property as provided for in this Agreement is made on an "as is" and "with all faults" basis. Effective upon the Closing Date, Athens and anyone claiming by, through or under Athens hereby fully and irrevocably releases the District and all other County Sanitation Districts of Los Angeles County, and their respective successors, assigns, partners, directors, officers, trustees, beneficiaries, members, employees, agents, lenders, attorneys and affiliates (collectively, the "District Parties") from any and all claims that it or they may now have or hereafter acquire against the District or any of the District Parties for any cost, loss, liability, damage, expense, demand, action or cause of action arising from or related to any matters affecting the Property. This release includes claims of which Athens is presently unaware or which Athens does not presently suspect to exist in its favor which, if known by Athens, would materially affect Athens' release of the District and the District Parties. Athens specifically waives the provisions of California civil code section 1542, which provides as follows:

"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."

The foregoing releases survive the Closing Date.

8. Tax. Athens shall be solely responsible to determine whether any sales, use, or similar taxes attributable to the sale and transfer of the Property by the District to Athens are due and payable and shall pay such taxes in a timely manner to the applicable taxing authority.

9. Miscellaneous.

a. This Agreement shall be binding upon, and inure to the benefit of, the parties hereto and their respective successors and permitted assigns. Athens shall not assign, transfer, sell, or convey its rights under this Agreement without the prior written consent of the District which consent may be withheld in the District's sole and absolute discretion.

b. This Agreement may not be modified or amended except by a written document executed by both Parties to this Agreement.

c. The captions and headings of the Sections of this Agreement are for convenience of reference only and shall not be deemed to define or limit the provisions hereof.

d. Each Party is duly authorized to execute this Agreement on behalf of that Party, that each Party by so executing this Agreement is formally bound by the provisions of this Agreement and that said Party has not sold, assigned or otherwise granted to any other person or entity, any claim, lien, demand, cause of action, obligation, damage or liability covered by this Agreement.

e. The Parties agree that this Agreement will be construed in accordance with the meaning of the language used and will not be construed for or against any Party by reason of the authorship of this Termination Agreement or any other rule of construction that might otherwise apply.

f. This Agreement will be governed by and construed pursuant to the laws of the state of California. Any disputes arising from this Agreement will be decided in an action or proceeding brought before the Los Angeles Superior Court. All Parties to this Agreement agree that the Los Angeles Superior Court will have exclusive jurisdiction to adjudicate any dispute arising from or related to this Agreement, to enter final judgments, and also consent to venue before the Los Angeles Superior Court.

g. If any provision of this Agreement is held to be invalid, void, or illegal by any court of competent jurisdiction, the remainder of this Agreement will remain in full force and effect. If any provision of this Agreement is deemed invalid due to its scope or breadth, that provision will be deemed valid to the extent of the scope or breadth permitted by law.

h. This Agreement including all exhibits, constitutes the entire understanding between the Parties and supersedes all other agreements, representations and warranties, oral or written, with respect to the subject matter of this Agreement. This is a fully integrated agreement.

i. No provision of this Agreement may be waived, modified or amended except in writing signed by all Parties whose rights are thereby waived, modified or amended. Waiver of any one provision of this Agreement will not be deemed to be a waiver of any other provision.

j. The Parties each agree to bear their own respective costs and attorneys' fees incurred in connection with the preparation and negotiation of this Agreement.

k. If any legal action is brought to enforce the terms and conditions of this Agreement, including the releases provided, the prevailing party in that action will be entitled to recover its actual costs, expenses and attorneys' fees in addition to any and all other remedies available by law or in equity. Each Party agrees that in the event any such legal action is commenced, that such party hereby waives its right to request a jury trial.

1. The individuals executing this Agreement on behalf of the District and Athens represent and warrant they have authority and power to execute this Agreement on behalf of the District and Athens, respectively.

m. The District's Chief Engineer and General Manager or his or her designee is authorized to take all actions on behalf of the District in connection with any approvals, consents, or actions required of or by the District to fulfill the purposes this Agreement.

n. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all, when taken together, shall constitute the entire agreement between the Parties. For purposes of this provision, a facsimile or electronic signature shall be deemed to be the equivalent of an original signature and shall be effective to bind a Party hereto.

IN WITNESS WHEREOF, the Parties hereto do execute and enter into this Agreement as of the Effective Date.
